NACO: Code Council Board makes historic vote approving newest Chapter

The Code Council’s Board of Directors voted unanimously at its October 18 meeting to accept the application of the first Native American chapter of ICC, the Native American Code Officials (NACO). The vote was followed by a standing ovation. NACO was incorporated in December 2023 by four Native Americans who are active in ICC and share a passion to utilize building codes as an additional means of empowerment for tribal nations and Indian Country. With the belief that building codes can promote tribal sovereignty, tribal health and safety, and tribal economic growth and empowerment, NACO quickly grew to coast-to-coast and today has over 50 members including members enrolled in over a dozen tribal nations and counting.

YOUR INPUT IS NEEDED: Survey provides insight for digitalization project

The “[Code Official Digitization and Efficiency Support \(CODES\)](#)” project, led by the International Code Council and other industry organizations, aims to aid building code implementation through a transition to electronic code enforcement processes, with a primary focus on resource-constrained municipalities. Through stakeholder input, the program will identify and address implementation barriers and provide training resources to support workforce development in code enforcement. We are seeking participants to complete our survey so that we can better understand the challenges that small and under-resourced building and fire prevention departments may encounter in transitioning away from paper-based systems. This work is part of the (CODES) project, an initiative funded by the U.S. Department of Energy. The project seeks to explore ways technology can help code departments save time and do more to advance their mission of advancing public safety and resiliency despite resource constraints. **The survey takes less than 15 minutes to complete. FEMA boosts federal share to communities enforcing newer code editions

The Federal Emergency Management Agency (FEMA) recently released an interim policy that would increase the amount of the federal government's cost share in post-disaster repair and reconstruction for public facilities from 75 percent to 85 percent for communities that have already adopted and enforce one of the two most recent editions of the IBC and IECC (or ASHRAE 90.1). **This means that the building safety work you do could bring significantly greater resources to your community during disaster recovery.** Why do updated codes matter? FEMA's *Building Codes Save* report noted the IBC helped avoid more than \$600 billion in losses, while the National Institute for Building Sciences *Mitigation Saves* study showed \$11 in mitigation savings for every \$1 invested. Three national labs found the IECC can reduce extreme heat deaths associated with disaster-induced power outages by 80 percent, or

extreme cold deaths by 30 percent. FEMA already requires the use of these codes for repair and reconstruction efforts. Providing additional funding for jurisdictions that adopt updated codes recognizes the importance of their mitigation benefits and will incentivize smart planning before disaster strikes. The International Code Council is now accepting proposed changes to the 2027 Group B International Codes® (I-Codes), with the submission deadline set for 11:59 p.m. PT on January 10, 2025. The I-Codes are a family of 15 coordinated, modern building safety codes that help ensure the engineering of safe, sustainable, affordable and resilient structures. The Code Council's code development process is transparent, accessible and inclusive, and all interested parties are encouraged to participate. Code change proposals will be heard at the Group B Committee Action Hearing #1 from April 27-May 6, 2025, in Orlando, Florida.

Here's what you need to know about first Committee Action Hearings #2

The International Code Council's first Committee Action Hearing (CAH) #2 begins October 23, 2025, and is set to be completed on October 31, 2025. There are nearly 400 comments on roughly 330 code change proposals. These proposals were originally heard at the Group A CAH #1 hearing in Orlando earlier this year and voted on last month in Long Beach. While essentially a continuation of CAH #1, CAH #2 will operate a little differently. Code Council staff want to ensure all participants are informed of these changes in order for the hearings to run smoothly.

PRC survey underscores public support for stronger building codes in communities vulnerable to extreme weather events

A recent [Pew Research Center survey report](#) sheds light on public support for stricter building standards in regions vulnerable to extreme weather events. With climate change increasing the frequency and intensity of these events, such as hurricanes, floods and wildfires, the push for more resilient infrastructure is gaining momentum across the nation. The survey found that a significant majority of Americans (73 percent) support implementing more stringent building standards in areas prone to extreme weather. This broad consensus cuts across political, geographic and demographic lines, highlighting a strong national desire for action to mitigate the impacts of climate change and enhance community resilience.

ICC-ES strengthens structure to unify leadership of testing and certification

ICC Evaluation Service (ICC-ES) announces changes to the senior management team, harmonizing the oversight of testing, inspection and certification services in order to better serve its customers.
